## WHAT ARE APPLICATION REQUIREMENTS?

The CFRE certification process has two parts: 1) a written application and 2) a written exam. Candidates must meet application requirements before they are permitted to test. The CFRE application works on a point system. Candidates for Initial Certification must document that they have met minimum point requirements in all of the following categories:

**EDUCATION.** 80 points required (must be within the past 5 years). Points can be earned by attending or teaching educational conference sessions or workshops on fundraising; by authoring publications on fundraising; through academic degrees; and service learning through volunteer activities.

**PROFESSIONAL PRACTICE.** 36 points required (must be within the past 5 years). This is the equivalent of 3 years\* of employment. Employment must be as a professional member of a fundraising staff or as a fundraising consultant to nonprofit organisations.

**PROFESSIONAL PERFORMANCE.** 55 points required (must be within the past 5 years). Points can be earned for actual funds raised, communications projects for fundraising, or management projects for fundraising. It is not necessary to document points in each category.

\*The CFRE exam tests knowledge of ethical fundraising practice at the 5-year level of experience. CFRE International recommends that applicants with less than 5 years of experience have extensive educational preparation in fundraising and/or significant transferable work experience.
