# Three Elected to CFRE International Board of Directors for 2018-2020

Alexandria, VA – 23 August 2017 – <u>CFRE International</u> is pleased to announce the election of **Elizabeth LeClair, CFRE** (Halifax, NS, Canada); **Jeffrey M. Norris, CFRE** (New Westminster, BC, Canada); and public member, **Mary Tschirhart, Ph.D., MBA** (Columbus, OH) to three year terms (2018-2020) on the CFRE International Board of Directors.

CFRE International is governed by a Board of Directors of eleven, including ten CFRE certificants and one public member. The Board strives to be representative and embrace diversity in the broadest sense. For this reason, CFRE International utilizes a slate of candidates for voting purposes, rather than a general election. This ensures that the Board mirrors the certificant population in its diversity, as best possible, and protects against any one group overly influencing board makeup through sheer voting size. The candidate slate is the result of an open nomination period followed by the vetting of nominees by the CFRE International Committee on Directorship, who determine the final slate of candidates.

This year the CFRE International Committee on Directorship, chaired by Heather R. McGinness, CNM, CFRE, had the task of selecting a slate of three candidates, including the public member to the Board of Directors. All current Board members whose terms expire at the close of 2017 have already served two full terms on the Board and were not eligible for reelection.

The slate of LeClair, Norris, and Tschirhart was elected by a 97.3% majority of current CFRE certificants who cast their ballots in the election closing 11 August, 2017. Their terms of service on the CFRE International Board of Directors will begin 1 January, 2018.
